 - b. Information on each sample: title, year, project context if applicable
 - c. If an audio recording is submitted, the access link must be shown in the PDF portfolio. It is not possible to upload audio files.
- 4) Image files
 - a. A maximum of three works as work samples. If series of works are submitted, they may consist of a maximum of ten elements each.
 - b. Information on each sample: title, year, project context if applicable
